SUMMARY

In line with the <u>Anti-Fraud Policy</u>, to manage and mitigate all levels of risk, ERS has implemented a monitoring strategy based on three lines of defence: **prevention** (training, assessment of Third Parties, internal rules and procedures), **detection** (whistle-blowing system, internal and accounting controls) and **remediation** (implementation of corrective measures and disciplinary sanctions) in the event of non-compliance. Within this framework, this Declaration of Interest is part of the first line of defence: prevention.

Introduction

SCOPE

In line with ERS' <u>Code of Ethics and Business Conduct</u> and <u>Rules of Procedure</u>, this Declaration of Interest applies to all ERS Agents, board members, and contractors, covering but not limited to, Auditors, Funders, Project Developers, and other Third Parties. This last group includes accounting firms, legal and technical consultancy, insurance services, suppliers, etc.

A conflict of interest arises when personal interests conflict with those of ERS, potentially hindering a stakeholders' capacity to execute their duties with impartiality and efficiency. Such conflicts manifest if a stakeholder or their immediate family members gain undue advantages from their role at ERS.

GUIDING PRINCIPLES

By filling out this Declaration of Interest, ERS Agents, board members, managers and Third Parties must disclose all actual and potential conflicts of interest, including any material transaction or relationship that could be expected to give rise to a conflict of interest.

Disclosure is required only for interests that pertain directly to ERS's operations. For instance, receiving payment for speaking at a conference hosted by an ERS competitor constitutes a conflict of interest. Conversely, compensation for a musical performance in an orchestra, which is unrelated to ERS's activities, does not.

Consequently, ERS Agents, board members, managers and Third Parties should disclose connections to any activities within the environmental and sustainability sector, especially those related to carbon markets and ecosystem restoration. Disclosures should also include associations with industries that contradict ERS' core missions. This includes but is not limited to industries that highly contribute to climate change, biodiversity loss, or disrespect to indigenous people and local communities.
